Tournament Rules

- 1. This tournament is open to all adult female/male bowlers who are members in good standing of the USBC. It shall be governed by the rules and regulations of the USBC and of the tournament director(s).
- 2. This is a team, doubles and singles tournament. An entrant may enter the team event twice provided at least 2 players change on second team. The entrant shall be allowed to bowl twice in the doubles event provided at least 1 player change on second doubles event. An entrant may cash in each team and doubles events entered. All events is optional. If entered more than once in any event, only the highest scores in each event count toward all events.
- 3. An entrant will use the highest 2017-18 summer or winter league book average. If none, the entrant will use their 2018-19 average of 21 or more games as of May 1, 2019. **Averages not on bowl.com shall require an average verification signed by entrant's local or state association manager.** All others shall bowl scratch. This tournament will be handicapped at 90% from 230.
- 4. The highest team and/or doubles events shall count toward the bowlers all events. 100% of the prize monies will be returned to the participants and will be awarded at a rate of one out of every five (5) entries. In the event of a tie, prize monies will be divided evenly. A special award will be presented to the highest all events scratch participant. \$500 will be added to prize fund.
- 5. USBC rules 319a-2 (10-pin average), and rule 319d (prize winnings) will be in effect.
- 6. Substitutes will be permitted with no more than two on a team and one on doubles and must take the place in the lineup of the original entrant. Team captains should notify the tournament director at their earliest convenience of any changes to the team entry.
- 7. Appropriate bowling attire required. No short shorts, spandex, and tube tops will be permitted.
- 8. The computer printout is the official score sheet. Games or frames that are irretrievably lost in the scoring process due to a computer malfunction may be re-bowled with the approval of the tournament director.
- 9. Tournament competition shall begin promptly at 9:00 am and 1:00 pm. A participant not in the bowling area and ready to bowl will receive a zero for each frame missed.
- 10. The management of the tournament shall be vested in the tournament committee. Any protest involving eligibility or playing rules shall be made in writing to the tournament director within ten days of the completion of the tournament.
